Cancer Cure Perspectives in this New Global Immunodeficiency

1. Introduction

Since 2015 we have been facing another type of immunodeficiency, where most of the world's population are considered immune-depressed caused by the modernization of telecommunication which was shown in the article written by Huang (2021) titled Energy Alterations and Chakras' Energy Deficiencies and Propensity to SARS-CoV-2 Infection [1]. She showed in this article the resulting measurements of the energy within the five internal massive organs pertaining to the five elements theory of Traditional Chinese Medicine where, at that time (2015-2020) prior to the COVID-19 pandemic, 90% of all her patients were at the lowest level of energy in all these five internal organs [1]. The problem nowadays is that doctors from Western medical schools have not had the chance to study the energy part of the human body, which has been studied by Traditional Chinese Medicine for the last 5000 years [2].

So, the energy part is not treated in most patients nowadays, instead the treatment focusses on the symptoms and not the real cause of the formation of disease, which brings us back to the energy part [3]. In another one of her articles titled Why Is Every Cancer Only the "Tip" of The Iceberg? she said that in the case of cancer long term energy deficiency (10 to 20 years) was necessary before the onset of the disease itself [4]. In the article titled What Are the Markers That Predict the Development of Having Cancer in the Future Without Laboratory or Radiological Tests? she showed that there is a necessity to treat the energy deficiency condition that is the cause of the formation of the majority of diseases nowadays, mainly cancer [5]. Why does she say to use this method instead of using radiological or laboratory exams? [5]. Because before alterations in the laboratory exams, there are alterations in the energy level, and even though the laboratory exams are normal, this does not mean that the patient does not have any risk of having cancer or another disease. In the study made in her clinic, even patients without any kind of disease had energy deficiency inside these five internal massive organs from the five elements theory of Traditional Chinese Medicine [1]. The progression from health

to disease is divided into five phases, and in the first three phases there are energy alterations but the laboratory exams are normal. Only in phase four, we can see alterations in the laboratory exams and if we do not treat this energy deficiency condition, it can evolve to phase four to five, characterized by all malignant cancer formations [6].

In another article written by Huang (2020) titled *The Importance of Treating Energy Imbalances and Chakras Replenishment for Prevention and Treatment of Cancer*, she presented three cases reports where the first had malignant thyroid cancer, the second had atypical cells at pap smear exam, and the third had lung cancer with metastasis in the whole body (the central nervous system, abdomen, skin and lymphatic ganglions) [6].

All of them had in common, energy deficiency in the five internal massive organs from the five elements theory of Traditional Chinese Medicine. After the treatment using Chinese dietary counseling, auricular and systemic acupuncture and replenishment of these energies using highly diluted medications according to the theory created by the author herself, titled *Constitutional Homeopathy of Five Elements Based on Traditional Chinese Medicine*, the first patient was cured of her malignant thyroid cancer proved by frozen biopsy in the surgery two months after the energy-based treatment. The second patient was cured from her condition of atypical pap cell exam after one month of treatment normalizing her pap cell exam, and the third patient also reduced his metastasis using this kind of therapy. This last patient had improvement of his metastasis condition using this kind of energy therapy but he was also using chemotherapy prescribed by his oncologist doctor.

As we were facing the COVID-19 pandemic at the time, he stopped using this energy-based treatment and continued only with his chemotherapy treatment prescribed by the Western medicine doctor in consideration of the COVID-19 pandemic. He started to decline with this health issue and died after one year of continuous chemotherapy [6,7]. What the author would like to emphasize in

this editorial is that we need to integrate the knowledge of ancient medical traditions such as Traditional Chinese Medicine and Ayurveda as well as homeopathy to the knowledge of Western modern medicine, because using these other points of view, we can integrate better what can see by the naked eye with what cannot which is the energy that exists inside the human body, that the majority of medical doctors cannot understand because this part of the human being is not taught in the medical schools, after the implementation of the Flexner report in 1910 [6,8].

So, to have more success or increase the survival rate among cancer patients, there is the necessity of having both kinds of medicine in mind because the modern medical system is only treating the symptoms caused by this lack of energy inside the five massive organs characterizing another kind of immunodeficiency as was shown in the author's article titled *New Global Immunodeficiency* [6,9]. The necessity to reevaluate the curriculum of all medical schools in the world is very important because of all the alterations that the modernization of telecommunications is at the energy level which is invisible to the naked eye. Furthermore, this is not taught by modern medical schools, mainly after the implementation of the Flexner report in 1910, changing all medical curriculum of these schools and iterating that the only medication considered scientific are the ones produced by the pharmaceutical industry [8].

We know that these medications are harming our energy even more and causing complications or even the death of these patients, because according to the Arndt-Schultz Law, created in 1888 by two German researchers, the use of any kind of highly concentrated medications such as antipyretic, antibiotics, anti-inflammatory medications, anti-depressant medications, chemotherapy, etc. can worsen this energy condition and can lead to the death of these patients [10]. Even vaccination, where highly concentrated ones are used, can also reduce even more this internal energy and cause complications such as myocardial infarction, stroke, diabetes, autoimmune disease or even more cancer, as shown in the article titled *Which Could Be the Risk Factors for Developing Cancer After Receiving The COVID-19 Vaccine* [11]. To finalize this article, the author would like to recommend the treatment of our internal energy which is so necessary these days to prevent or treat

any kind of disease, including in this case, all kinds of cancer and to increase the chance of having a real cure for this disease and not curing only the symptoms caused by the energy deficiency condition [12].
