3. Description of the Measurement and Measurement Method


The data collection takes place in the following way: the person is in a sitting position, moves the head and stretches various muscles of the head: those of the neck, those around the jaws and those around the ears, those on the forehead and around the nose.

The cell phone is placed with the microphone hole at a distance L (0.10 ± 0.05) m from the muscles subjected to tension.

To perform measurements with this application, you have to select the 'Audio width' function of the application, calibrate the instrument with a known value and then make the measurement.

4. Data Collected



In the screenshot there is a graph where in the axis of the ascisse is placed the time in seconds and in the axis of the ordinates the sound pressure level in decibels The author of the study believes that each peak around or above 50 dB corresponds to a noise emitted by the structure - dark substance that wraps around and penetrates the tensed muscles.

In this measurement, a structure at the base of the nose near the

nostrils was stressed. In 40 s, about ten pops were produced. The value of 35.9 dB is close to the background noise that was present in the room during the measurement.
