

# New Medicine Using the Voice Frequencies of Holographic Sound Records for Diagnosis and Healing

**Editorial**

Since we are not consciously aware of the functioning of our organs, their function must be ruled from the Subconscious. From people who see with their subconscious mind when they are blindfolded, we know that they see holographic tri-dimensional images [1]. Since holographic images are created only with the waves of laser light in the visible spectrum, obviously the subconscious holographic images are created with waves in the visible spectrum [2].

Since sound is waves in the sound spectrum, we can expect the sound recorded in the subconscious brain to be holographic, just as the tri-dimensional holographic light images are. What about holographic sound? Hugo Zaccarelli in Argentina was the first to invent in 1980 holographic recording, which is different from the stereo recording. Can such holographic sound record be used for diagnosis and healing of our organs?

I studied for more than 30 years the aura and I found it to be emotionally sensitive – brighter at positive emotions and dimmer at negative emotions. I found it to be weak nonlinear electromagnetic field (NEMF). Since we say we are in high Spirit when we experience positive emotions and we say we are in low Spirit when we experience negative emotions, I concluded that the aura must be our Spirit.

Then I found that the ancient Jewish Cabala was teaching to high priest that the aura is our Spirit, which meant that I discovered a well forgotten ancient wisdom. Since hypnotists found that hypnotized people with sleeping Conscious calculate at least 10,000 times faster, I decided that we must have a powerful computer in the Subconscious.

Since we are not consciously aware of the functioning of our organs, their functioning must be ruled from the Subconscious, probably by the same powerful computer. Since the functioning

Bioacoustics Institutes can develop techniques that record holographically the human voice and create Vocal Profile, which can be used to accurately quantify and interpret from the missing frequencies in the human voice the state of health or disease of the talking individual.

Vocal Profiles can be used as a tool to identify and interpret the dynamics of the processes within the body. These holographic sound-recording techniques could provide insight into the possibility to use the missing frequencies in the Vocal Profile to predict oncoming changes in the human physiology and psychology. I claim this because from pulse diagnosis we know that by monitoring the frequencies and amplitudes of the pulse, we can detect diseases, which will manifest with symptoms 5 to 7 years later.

Sherry Edwards pioneered the innovative concepts and ideas associated with Human Vocal Profiles [3], but she was using normal not holographic records of the voice. She claimed that

the successful applications of the Vocal Profiles will include pre-screening to predict (and prevent) an oncoming disease. She was even considering as a dream project for the future to discover frequencies that accelerate bone healing, increase muscle strength, and alleviate tension and pain in joints and muscles. These are dream projects that cannot be achieved with normal sound record – the record must be holographic.
