Ovarian Dermoid Cyst: Ruqya and Negative Ions Treatment

Abstract

Dermoid Ovarian Cyst or Mature Teratoma, can be dreadfully looking because they look like a small human being in the ovary containing the teeth, hair, bone, endocrine tissue, brain, respiratory tissue, colon, eye, extremities and even penis. The world Teratoma is derived from "Theres", the ancient Greek word for "monsters" and "beasts". Additionally to the strange composition, the extra-ovarian location and diffusion, recurrence, occurrence in men and children, association with psychiatric demonic possession symptoms, the origin of the word Teratoma meaning "Monstre", recovery with Ruqya treatment: all these prove the involvement of the hidden Evil Jinn as the name "Theres" indicates. Psychiatric symptoms initially were attached to the Anti-NMDA-receptor Encephalitis found in Ovarian Teratoma but later the same Encephalitis were found also in men, children and women without Ovarian Teratoma. This is also emphasizing the Jinn involvement including the family history, personal history of the patients. The best treatment is Ruqya associated to Negative Ions for the quicker and better results.

Introduction

Dermoid Ovarian Cyst or Mature Teratoma, can be dreadfully looking because they look like a small human being in the ovary containing the teeth, hair, bone, endocrine tissue, brain, respiratory tissue, gastrointestinal, eye, extremities and even penis.

"Theres" is the ancient Greek word for "monsters" and "beasts" [1]. Mature Teratomas are embryonic tumors that normally arise from well-differentiated germ cells and are typically benign even with extra-ovarian diffusion like a cancer. They are defined as being composed either of tissues that are foreign to the area in which they form, or of tissues that derive from all three of the germ layers: endoderm, mesoderm, and ectoderm [2].

Mature Teratoma may contain any tissue

Hair, fat, skin, teeth, eye, gastrointestinal tissue, bone, cartilage, muscle, endocrine tissue, respiratory tissue, brain and skull, glia, neural tissue, retina, choroids, ganglia, fibrous tissue, mandible-like structure with teeth, extremities, penis. [3-5].

Mature Teratoma can be located in the different places [6-11]

Sacrococcygeal: the most common location Gonads: Ovarian and Testicular Teratoma Brain Mediastinal Intraperitoneal Retroperitoneal Lung

Abdominal Pancreatic Nasal Sinuses Orbital Cervical Spinal Cord Tailbone

Age and Sex Prevalence

The highest incidence in women of reproductive age

Familial occurrence of Mature Ovarian Teratoma

Mother and two daughters [12-14] Identical twins [15-17] Grandmother and granddaughter [18] Ovarian Teratoma in three generations [19, 20]

Ovarian Teratoma and Anti-NMDA receptor Encephalitis [21-24]

Ovarian Mature Teratoma with psychiatric demonic possession symptoms have been initially linked to Encephalitis associated with antibodies against the N-methyl D-aspartate receptor (NMDAR). This Encephalitis was first diagnosed by finding the specific antibodies in the cerebral spinal fluid in four patients with Ovarian Teratoma presenting psychiatric demonic possession symptoms by Dr Josep Dalmau in 2007.

Anti-NMDA receptor Encephalitis was later found also in men, children and women without Ovarian Teratoma.

Published cases in favor of the Jinn involvement

Some published cases describe the past history which helps to understand better the cause of the Dermoid Cyst in the light of Quran and Hadith

Case 1

16 y -old girl with pelvic pain and dysmenorrhea due to Right Ovarian Dermoid Cyst measuring 5 cm. Laparoscopic Ovarian Cystectomy was performed, Left Ovary was normal. Postoperative visit one month after the surgery with clinical improvement and no Ovarian Cyst.

One year later she presented with two months continuous bleeding. Ultrasound revealed the recurrence of the Right Ovarian Dermoid Cyst measuring 4 cm which was removed by the 2nd Laparoscopic Ovarian Cystectomy. Left Ovary was normal

Three years later, she presented abdominal intermittent pain, dysmenorrhea for several months. MRI revealed Right Ovarian Complex Cyst 5 cm and Left Ovarian Complex Cyst measuring 9 cm, with CA-125 high (was normal before). Laparotomy with bilateral Ovarian Cystectomy was performed for Dermoid Cysts containing fat and hair [25].

What **Hadith** tells about **continuous bleeding**: Hadith recorded by Al-Bukhari;

When Hamma bint Jaash asked the Prophet (piece and blessing be upon him=pbuh) about the issue of prolonged bleeding even after the period of menses, the Prophet (pbuh) said: "Such bleeding is but one of Satan's stomping." (Tirmidi, Bukhari)

Continuous bleeding, recurrence and expansion of the disease: due to the Jinn involvement

Case 2

40 y-old woman with premature menopause at the age of 38, had Laparotomy for Ovarian Cystectomy Right Dermoid Cyst measuring 5 cm, containing mandible with teeth, sebaceous glands, skin, connective tissue, neural tissue, keratin, collagen, fat, mucinous material [5].

Premature Menopause and Ovarian Dermoid cyst are the signs of the Jinn Involvement

CASE REPORT of RECURRENT DERMOID CYST TREATED by RUQYA and NEGATIVE IONS

Patient A, 24 years, obese, height 170 cm, weight 106 kg. Primary Infertility three years. Had six months before visiting me Laparoscopic Bilateral Cystectomy for Bilateral Ovarian Dermoid Cysts: in the right ovary measuring 2.5 cm and three cysts 6, 5 and 1.5 cm in the left ovary. Dermoid cysts contain epiderme, neuroglial tissue, pilosebaceous unit, cartilage, respiratory tissue. Post-operative ultrasound done one month after the surgery was normal.

She was complaining of constant pelvic pain. Vaginal ultrasound showed Left Ovarian Dermoid Cyst 3.7 cm which appeared in the short time of period after postoperative visit. The nature of the Left Ovarian Dermoid Cyst was confirmed by Pelvic MRI.

As pelvic pain was increasing and constant she went to the hospital and did additional tests: blood test, vaginal swab and urine tests which were normal.

Usually, Dermoid cyst of this size is asymptomatic, constant pain was unusual. As previously she had already laparoscopic surgery on both ovaries, repetitive surgery may decrease the ovarian reserve in this already infertile patient.

I suggested her Negative ions (Ionbox with 20 million Negative Ions and Anion Sanitary Napkins) and Ruqya treatment for 2 months. Pain disappeared. Ultrasound reveled normal 45 days later. Ruqya was performed by patient according my instructions.

As the treatment with Ruqya associated to Negative Ions was successful, the origin of the Infertility, Obesity, Ovarian Dermoid Cyst and Pelvic Pain is the presence of the Jinn Possession, most probably by attraction, love or Black Magic.

Discussion

As the word of the Teratoma derived from the ancient Greek "Theres" which means 'Monstres" and "Beasts", these patients with Ovarian Teratoma, bizarre tumor, strange composition, should be investigated carefully, taking in consideration family and past history, their lifestyle, habits, behavior, the way how they sleep, their dreams, if depressed, anxious, obese, infertile, menstrual irregularity, sexual disorders, presenting headache etc.

Ovarian Teratoma might not be necessary to produce the Encephalitis with NMDA Receptor Antibodies as this Encephalitis was found in men, children and women without Teratoma [23-24]. Patients with Teratoma ("Monsters") may develop Demonic possession symptoms regardless of Encephalitis or no.

The teeth or brain cannot move from one place to another but Jinn with their supernatural power can move everything and capable create any disease.

The Unseen World of Jinn (Satan, Shaytan, Devil) was described in the references [26,27,31,32]. Hadith telling about about Sihr Black Magic an-Nazeef (Prolonged Menstrual Bleeding). An-Nazeef refers to Continuous Menstruation, or Bleeding. A witch sends Jinn to the targeted woman and to cause her bleed. To do so, the Jinn enter the woman's body and circulate in her veins and arteries with the blood. Prophet (piece and blessing upon him) said:

"Verily, Satan (Shaytan/demon) flows in the human like the flowing of the blood."

(Bukhari and Muslim (An-Nawaawi, 14/155)

In another Hadith recorded by Al-Bukhari; When Hamma bint Jaash asked the Prophet about the issue of prolonged bleeding even after the period of menses, the Prophet (piece and blessing upon him) said: "Such bleeding is but one of Satan's stomping." (At-Tirmidi, Al-Bukhari). Imam Ahmad confirms another report that in fact the Prophet (piece and blessing upon him) said: "The bleeding is the result of Satan's stomping on a VEIN rather than from a normal menses." (Imam Ahamd – An-Nasa'i)

The Hadith imply that the continuous bleeding outside its normal period is the effect of a Jinn (Shaytan, Satan). Jinn can possess the humans out of attraction/love, by revenge; can be sent by Black Magic; also when people deal with RIBA (bank interest), when the people leave Islam as Allah protects the believers worshiping Him [31,32].

Ruqya Treatment

Ruqya (recitation of certain verses of Quran) treatment should be started at earliest regardless surgery or no. Ruqya has curative and protective effects and brings nothing but good. The cure is only from Allah.

Ibn-ul-Qayyim said: "The Quran is the most complete cure from all physical and psychological illnesses - the illnesses of this world and the illnesses of the Hereafter. Not everyone is capable, nor is everyone given the success from Allah to seek a cure from it. If the sick person uses the proper method of using the Quran as a medicine, with belief complete faith and acceptance, and firm belief in it as a cure, and he fulfills all of the conditions [of doing so], no disease will ever overcome him. How can a disease overcome the speech of the Lord of the Heavens and the Earth, the speech which if it was sent upon a mountain, would render that mountain to dust. The speech that if it was sent upon the earth, would break the earth into pieces? There is no illness of the heart and the body except that the Quran contains the means to guide how to cure it, why it happens, and how to protect from it, for those whom Allah gives the understanding of his book. As for the diseases of the heart, Allah mentions them in detail along with their causes and the method of curing them. So, the one who is not cured by the Qur'an, may Allah not cure him, and the one who the Quran is not sufficient for him, May Allah not suffice him in anything! It is known that certain things that we say have particular special qualities and proven benefits, then what do you think of the speech of the Lord of the worlds, the one who the virtue of his speech over the speech of others, is like the virtue of Him over his creation. The Quran is the perfect cure, and it is a beneficial means of protection, and a guiding light and a general mercy. If it was sent upon a mountain it would render it asunder from its greatness and its glory [30].

"Shifaa': A medicine for the ignorance which resides in the hearts, by which Allah cures the ignorance of the ignorant people, and by which Allah cures their sickness, and by which Allah guides whoever he wills of his creation." (Al Tabari)

The Messenger of Allah (piece and blessing be upon him) advised people to perform Ruqyah on others, regardless of whether or not they ask, such as the Hadith in which he said, "Whoever is able to help your brother let him do so". Narrated from Ibn 'Abbaas (may Allah be pleased with him) that the Messenger of Allah (peace and blessing be upon him) said: "Seventy thousands of my Ummah will enter Paradise without being brought to account; they are the ones who did not ask for Ruqya or believe in omens or use cautery and they put their trust in their Lord." (Bukhari, 6472 and Muslim, 220)

There is another wording of the narration: "and with every one of them [the seventy thousand], there are seventy thousand more," so do not despair of the Mercy of Allah.

Ibn Al-Qayyim (may Allah have mercy on him) said: "That is because these people will enter Paradise without being called to account because of the perfection of their Tawheed, therefore he described them as people who did not ask others to perform Ruqya for them. Hence he said "and they put their trust in their Lord." Because of their complete trust in their Lord, their contentment with Him, their faith in Him, their being pleased with Him and their seeking their needs from Him, they do not ask people for anything, be it Ruqya or anything else, and they are not influenced by omens

and superstitions that could prevent them from doing what they want to do, because superstition detracts from and weakens Tawheed." (Zaad al-Ma'aad, 1/475)

Surah Al-Fatihah is a Ruqya and it is from the greatest of that which can be used as a Ruqya for the sick person, should be repeated seven times. (Quran, Al Fatihah, 1)

Surah Al Ikhlas, Al Falaq, Al Nas (Quran 112-114) (three times or impair number)

Surah Ayatul Kursi (Quran, Al Baqarah 2: 255)

Last 2 verses of Surah Al Baqarah (Quran, Al Baqarah 2:285. 286), full or partial Baqarah

Other Surahs

For ruling on Ruqya, please, refer to [26-32]. The person performing Ruqya should follow the Allah's commands and prohibitions. In my personal experience, Allah The Almighty cured disbelieving people as Allah knows their heart, good deeds, good conduct and their future. Allah The Almighty says in Quran that He forgives everyone who asks forgiveness.

Negative Ions Treatment
