

Starting from The Reform of the Basic Economic System, We Should Truly Realize the Common Prosperity of Scientific Socialism

Abstract

Starting from the basic economic system of true scientific socialism, this paper argues that in the development stage of socialism with Chinese characteristics in the new era, we should continue to reform the existing Chinese economic system and make it conform to the nature of modern great productive forces so that it can give full play to the enthusiasm, initiative and creativity of socialized great productivity organizers, intellectual property owners and human resource teams; That can not only promote the conscious development of economy, but also realize the conscious social fairness and common prosperity of social members under the new economic system.

Introduction

On the occasion of celebrating the 100th anniversary of the founding of the Communist Party of China and China's declaration of building a moderately prosperous society in all respects; China's reform and opening-up has also entered a critical juncture. In "The Awakening Era" ---a TV series to commemorate the 100th anniversary of the founding of the Communist Party of China, how did the founder of the Communist Party of China seek a new path of the Chinese revolution before the founding of the Communist Party of China was explained. But now at this juncture, it is to request Chinese communists to find a way to promote the development of the whole existing Chinese society consciously and realizing the self-conscious development of scientific socialism for the whole society, realizing the most advanced form of development of Chinese society in the world and the great rejuvenation of the Chinese nation, and leading mankind to embark on the glorious path of self-conscious development.

This road which can promote the development of the whole existing Chinese society consciously is to start from the basic economic system of true scientific socialism, reform the existing Chinese economic system comprehensively and deeply, make it conform to the nature of the modern great productive forces, promote the rapid development of China's modern great productive forces and promote the rapid increase of social wealth, and according to this

basic economic system's nature request, reform social distribution system, promote social member's common prosperity and conscious development. Now, let's expand on that.

The Basic Economic System of True Scientific Socialism

In previous works, the author has gradually clarified the basic economic system of true scientific socialism with the passage of time [1-3].

The basic economic system of real scientific socialism is the basic economic system that must conform to the nature of the great modern productive forces and can promote their development.

Modern socialized productive forces must consist of organizers of socialized productive forces, intellectual property owners, and human resource teams capable of completing and being competent in the technological process of production stipulated by intellectual property rights, producing products or providing social services; that three parts must under certain social conditions, only by consciously forming an organic whole, i.e. enterprises of various sizes, can real productivity be formed. Therefore, according to the nature of the development of socialization great productivity must be consciously, as a whole, enterprise's ownership (equity), if inherit the most developed social existing property rights system- joint-stock system, the organizers of the social great productivity, the

intellectual property owner, and the HR team (meet the above conditions) should share the ownership of the enterprises; Because the three parts in the organization and operation of the enterprise, are the same indispensable part; Generally, the three parts place holds position same, three parts should hold same share right: namely each part holds integral share right each 1/3, this is the origin of three third joint stock system.(In some enterprises, the functions of the organizer of socialized productivity, the intellectual property owners and human resource teams can vary significantly. The share ratios of the three parts can vary; The main change is usually the intellectual property section; For example, if the technical content is low and the HR team plays a major role, the proportion of intellectual property can be appropriately reduced and the proportion of HR team can be increased.)

Of course, capital plays a very important role in the formation of socialized great productivity. It can be raised by the society, invested by investment institutions, or invested by individuals or several partners. In essence, it represents the old social wealth and constitutes the material basis of the new social productive forces. It is the necessary condition of the new social productive forces. But it is not a decisive component of socialized great productivity. (Having money does not necessarily constitute socialized great productivity). However, the use of capital is equivalent to the application of the accumulated wealth in the past, and of course it must pay a certain price, namely the interest of the use (which can and should be included in the production cost of the enterprise). But it is not necessarily a reason to own shares. In the previous argument, we implicitly assigned the role of organizer of socialized great productivity to capital (because for most of history, capital investors did play the role of socialized organizer of great productivity). So, in the previous, less rigorous argument, we gave one third of the equity to the capital, but that should be given to the organizers of socialized great productivity. In the latest rigorous discussion [3], we have corrected this inaccurate statement and renamed the "three third Joint-stock" system: namely, the socialized great productivity organizer, the intellectual property owners and the corresponding human resource team each own one-third of the ownership of the enterprise.

The organizers of socialized great productivity take advantage of their organizational ability and organizational role (organize capital-previous social wealth, intellectual property rights and human resource teams to form an organic social entity and complete the production or service needed by the society) and the intellectual property rights owner (by virtue of the intellectual property rights owned and invested to play a social role) obtains one third of the corresponding property rights respectively; The corresponding human resources team, which does not need to invest but only take into the production or service process, should own one-third of the property rights. Because only with their input, the old social wealth (capital and other goods) can realize the transfer and appreciation of its value and realize the fundamental social goals of enterprises. Human resource team should own one third of its property rights without investing but only taking part in the production or service process is the fundamental difference between the real socialist economic system and the capitalist economic system; If we do not see this clearly, our socialist economic reform will lose its fundamental goal!

It is an inevitable requirement and practice of capitalism to invest capital and hold the shares of enterprises. But this is capitalism, absolutely not scientific socialism.

Due to the diversity of individuals in the society, people's birth environment, family environment and social environment are also uneven, and people's social education level is different, which determines that in the society, everyone can complete social work and tasks are also varied; Therefore, people in various social positions, the wages obtained (social income), also differ. This is a social phenomenon that can occur at any time and under any social conditions. Therefore, under the condition of modern socialized great productive forces, under the social premise that human society has objectively entered the period of self-conscious development, such phenomenon will still appear and produce; Therefore, for the socialist economic system in line with the development nature of socialized great productive forces, within the human resource team, different jobs are caused by different abilities and different social environments, and the wage income has relatively truly reflected the social consequences caused by differences in individual abilities. As a member of the human resource team, although their positions are different, they are all indispensable (if they can be cut, there is no need to set up this position), and they are all indispensable members of the whole human resource team; They are in the same position in the production or service chain of the whole enterprise, so all HR team members should have the same position when sharing the 1/3 equity of the HR team. This is the author's latest statement on the distribution of the one-third stake. The reason is: the ability difference of each member of the Human resource team has been fully reflected in their salary income (salary difference also fully reflects the principle of distribution according to work). No matter how big or small their abilities are, they must cooperate equally in the same social production or social service organisms to ensure the normal operation of the organism. So their share of that third stake should be equal. A functioning social organism cannot do without a CEO, nor can it do without the most ordinary worker; Lack of which post, it must be replaced immediately, otherwise, the enterprise will stop, resulting in more serious losses.

In summary, the conclusion is that: in general, the social productivity organizer, the intellectual property owners and the corresponding human resource teams (without investment) should each own one-third stake of the enterprise. And the human resources team members should share the 1/3 equity in a completely equal position. This is the basic principle of the basic economic system and distribution system of true scientific socialism. (It not only implements distribution according to work, but also implements social fairness.)

In the society where modern socialized great productive forces occupy the main position, enterprises of whatever nature should implement this basic economic system and distribution system, so as to truly promote the development of modern socialized great productive forces and social equity and common prosperity.

The Current Situation and Reform Path of China's Existing Economic System

Since China's reform and opening up, under the guidance of the theory of socialism with Chinese characteristics, after several

twists and turns, the current situation of China's existing economic system is that the state-owned monopoly enterprises implement the state monopoly capitalism; After several waves of reform, general state-owned enterprises have been transformed into joint-stock enterprises and adopted joint-stock capitalism; Private enterprises, which account for the bulk of the country's GDP, practice capitalism at all levels of development; So, strictly speaking, all of China, with the exception of a few individuals (such as the Huawei Group and its ilk, as well as the emerging so-called partnerships), practices capitalism in one form or another.

To truly promote the rapid development of the productive forces in China as a whole, we must begin with the reform of the basic economic system of the whole society. We must first carry out experiments in various enterprises to gain experience, and then apply them to other enterprises to gradually realize the reform of the basic economic system. We will classify them in detail as follows.

- For private enterprises, we should distinguish the main identity of capital contributor and productivity organizer; Capital investor main body should obtain income according to the capital is used (according to the market investment interest, or should get the rate of return), from the enterprise return, this part should be included in the production cost of the enterprise; Those who truly play the role of productivity organizer (those who participate in enterprise management and operation and whose wages are included in enterprise production costs) occupy one-third of the equity of the enterprise and can share one-third of the profits of the enterprise; They are both capital investors and productivity organizers, and both have their rights and interests at the same time, but capital returns come first and are included in the costs of the enterprise, while equity returns (sharing one-third of the profits) must come after the profits of the enterprise; If the enterprise loses money, the productivity organizer must bear the corresponding responsibility (this responsibility should be greater than the proportion of its shares, since the main responsibility for the enterprise's loss lies with the organizer).

The intellectual property required by the enterprise can be directly joined by the intellectual property owner to obtain one-third of the equity of the intellectual property owner. In addition, the intellectual property can also be realized by a third party who buys the intellectual property from the intellectual property owner and puts it into the enterprise. In this case, one third of the equity that the intellectual property should have is owned by the intellectual property provider.

The human resources team of the enterprise as a whole, without investment, should have one-third of the equity of the enterprise; Not only does it share a third of the profits, but it should, and mostly should, vote on the day-to-day running of the business; The human resource team of the enterprise as a whole should have one-third of the representation in the decision-making body of the enterprise (such as the board of directors and the board of supervisors) (productivity organizer and intellectual property owner also has one-third of the representation respectively) to participate in the decision of all major matters related to the enterprise (major personnel appointment and removal of the enterprise, direction of production or service, decision of salary, decision of major projects, major capital flow and profit distribution, etc.).

After realizing the reform of the basic economic system, we can give full play to the enthusiasm, initiative and creativity of the three main components of socialized great productive forces, so that enterprises can take the right track of self-conscious development.

- The general reform of joint-stock enterprises with public ownership can refer to the economic system reform steps of private enterprises to gradually complete the establishment and daily operation of the basic socialist economic system.
- The state-owned monopoly enterprise implements the state monopoly capitalism, and its reform of establishing the basic socialist economic system has certain particularity, which is discussed in detail in a special section.

The Basic Road of Carrying Out the Socialist Basic Economic System Reform in State-Owned Monopoly Enterprises

China's existing state-owned monopoly enterprises are implementing a certain form of state monopoly capitalism; Its manifestation is that the state set up the state-owned assets management committee to manage enterprises on behalf of the state as an investor, but in fact only the appointment of enterprise leaders; It is not clear that officials selected and appointed with bureaucratic seniority and obscure nuances are up to the task of socializing great productivity organizers (or organizing teams of organizers) that their position entails; because there is no detailed qualified and professional job description.

All the major issues in the operation of state-owned monopolies, such as operating policy, price of products (services), salary structure of human resources teams, and profit distribution - how much is handed over to the state - are decided by the leaders; There is no trace of the basic socialist economic system (ordinary workers have no right to participate in decision-making); Hence it is called crony capitalism.

However, the state-owned monopoly enterprises are state-owned assets owned by the whole Chinese people since the founding of the People's Republic of China and accumulated at the expense that workers and employees only receive living expenses, farmers pay agricultural taxes and have to endure price scissors; Its operations and benefits must, of course, be carried out by institutions that represent all the people.

The state-owned monopoly enterprise is different from the general enterprise in its business scope and business category. It has natural national scope or local whole scope monopoly; Such as the supply of electricity and water resources and the use of wired or wireless communication services, all kinds of military production enterprises and so on, commonly known as electric hegemony, water hegemony, communication monopoly and so on.

Due to historical reasons, these monopolistic operations have gradually formed into state monopolistic enterprises since the founding of new China. The long-term economic system is essentially state monopoly capitalism; The difference between it and the general enterprise is: the business scope is naturally regulated by the state monopoly; Prices of products or services are also set by the state monopoly; The intellectual property rights needed by enterprises are derived from the research institutions established by the state

or the scientific and technological achievements of universities and scientific research institutions funded by the State, and the state is the contributor of the actual purchase of intellectual property rights. Therefore, in state-owned monopoly enterprises, the three components of socialized great productivity, the organizers of great productivity and the intellectual property owners are very different from the general enterprises.

For the organizer of great productivity of state-owned monopoly enterprises, he does not need to consider the scope of business and sales of products or services; There is also little power over the right to purchase intellectual property rights or the right to determine the price, because these are determined by the leaders above (the relevant agencies of the government, which are the superior authorities of the enterprise); (This is why SASAC ---State-owned Assets Supervision and Administration Commission--- only needs to appoint a chief executive to keep a huge state-owned monopoly in operation. Of course, it is also why the current state-owned monopoly is far less efficient than private enterprises and is called crony capitalism. It is also the fundamental reason that enterprise leaders can freely squander and waste state-owned assets, and even produce huge corruption).

The direction of the reform of the basic economic system of state-owned monopoly enterprises is still to give full play to the initiative and creativity of the three components of socialized great productive forces so as to promote the rapid development of state-owned monopoly enterprises; Although due to the particularity of state-owned monopoly enterprises, the real organizers of socialized great productive forces do not play as big and as much role as the organizers of general enterprises, there still have many places where they must give full play to their intelligence and wisdom under the framework of state monopoly; (such as choosing the right intellectual property right to purchase and the operation mode and structure of the whole enterprise; the scientific expectation and corresponding preparation and development of the long-term development of the enterprise, etc.), all need the organizer's conscious play. Therefore, the state-owned monopoly enterprise's actual productive organizer team, though not like general enterprise, let them occupy one-third stake in the enterprise, (because is the monopoly, enterprise's many fundamental questions have been settled by the state), but must also give them a certain equity incentive (generally should be around 1/6 to 1/10 of the total property, the specific proportion, should be evaluated by national Power departments, such as the relevant ministries and commissions of the National People's Congress authorized the corresponding evaluation institutions and finally determined by the relevant state power departments), to really promote the scientific development of state-owned monopoly enterprises; After deducting this part, the remaining equity (about 1/6 to 7/30 of the total equity) should be owned by the whole people, which is determined by the characteristics of state-owned monopoly enterprises.

One third of the equity to be owned by the intellectual property shall be owned by its owner; But since most of the INTELLECTUAL property products applied by state-owned monopolies are state-funded or bought out, the equity in these products is, of course, owned by state-owned enterprises.

One third of the equity the human resource team should have , of

course, belongs to the whole human resource team of the state-owned monopoly enterprise; each member of the human resource team should share this equity with the same status; (Although their wages can vary widely, reflecting the social income difference of different positions, but as a socialist country, the difference between the minimum wage and the maximum wage should also be reasonably limited, which should be determined by social legislation); This is one of the fundamental characteristics of state-owned monopoly enterprises withdrawing from the state monopoly capitalist system.

To sum up, the basic economic system reform of state-owned monopoly, is to abolish the state monopoly capitalism: countries as the representative and of the stakeholders in state-owned enterprises, because of its productive organizer role and possess from 1/6 to 7/30 of the total equity, (about 1/6 to 1/10 to organizer team of productivity, to give full play to their self-consciousness), and one third interest in the intellectual property acquired by purchase or financing (an independent interest if there is an independent provider of intellectual property, which is deducted from this part and the State interest is reduced by the corresponding portion), at last constituting approximately (1/2 to 17/30) of the total interest.

The true productivity organizer team of the state-owned monopolies holds about 1/6 to 1/10 of the total equity (as determined by the statutory appraisal process).

The entire human resources team of the state-owned monopoly owns about one-third of the total equity (no investment is required, and each member of the team has equal rights to share the equity).

In the daily operation of state-owned monopoly enterprises, the corresponding representatives form decision-making bodies such as the board of directors according to the proportion of equity to decide all major issues of the enterprise (production or service operation direction and mode, R&D development strategy and development direction and scale, nationwide layout, wage structure, personnel appointment and authorization, profit distribution, etc.).

If a state-owned monopoly enterprise suffers losses, the State shall, in accordance with legal procedures, establish an investigation committee to investigate the liability of enterprise for losses.

It is believed that after the reform of the basic economic system of state-owned monopoly enterprises in China, the three components of socialized great productive forces will give full play to their consciousness and creativity, promote the rapid development of state-owned enterprises, and create higher efficiency than private enterprises. Because compared with private enterprises, the production scale and the development level of socialized great productive forces of state-owned monopoly enterprises are not in the same league. As long as the economic system is reformed, the consciousness and creativity the whole human resources team can be inspired by is unlimited!

Reform of The Social Distribution System

The description of socialist distribution system by Marxist classical writers seems to be the principle of distribution according to work in people's memory today. Due to the China has long been at the primary stage of socialism of low development level of pro-

ductive forces, one of the most striking aspects of the theory of socialism with Chinese characteristics, is to develop social productive forces by give full play to the enthusiasm of all kinds of social mode of production, therefore, should be allowed to a certain range in line with the productivity development level of the development of the non-socialist public ownership enterprises; This is the theoretical basis for allowing private capitalism to develop in China. This is in full accord with the Marxist basic principle that relations of production must conform to the development level of productive forces. (This is the principle behind the bankruptcy of the people's commune system with "either big and public" under the condition of small productive forces, which is not suitable for the development level of small productive forces).

At the same time, socialism with Chinese characteristics also holds that China should open its door to the rest of the world for economic exchanges. The purpose is still to develop China's economy and gradually catch up with the advanced world level. This is the origin of China's great reform and opening-up process; It was The Chinese Communists represented by Deng Xiaoping who, with unprecedented historical courage, crossed the river by feeling for stones without the guidance of modern Marxist theory, finally opened up the great process of reform and opening up for the Chinese people and fought their blood way out; With the 18th National Congress of the Communist Party of China as the symbol, The Chinese Communists have crossed over the stage of unwitting development by feeling for stones, and entered a relatively conscious stage of development: In the theoretical journal of the Communist Party of China, it has been clearly published that we should consciously exert the reaction of the superstructure to the economic foundation, so as to actively promote the development of socialized great productive forces [4]. This is a great progress in the theory of the Communist Party of China, she has recognized the modern society must consciously develop and the basic principle of how to realize conscious development.

This is the most prominent feature of Xi Jinping's Basic Thought on Socialism with Chinese Characteristics for a New Era: Under the new concept of development, Chinese Communists must consciously exert the self-conscious reaction of the superstructure on all aspects of society to promote the all-round self-conscious development of Chinese society; The establishment of the CPC Central Leading Group for comprehensively Deepening reform is a significant symbol; Since its establishment, the group has initiated a number of reform measures on its own initiative (also known as top-level design) and made considerable progress. This kind of initiative and consciousness is the remarkable feature of promoting social development consciously.

At present, the Central Economic Work Conference held by the Communist Party of China echoes the experiment of how to achieve common prosperity launched in Zhejiang, and puts forward the great goal of making the society gradually achieve common prosperity in the next stage; The reform of the social distribution system is also on the agenda; The basic idea proposed is to change the focus on efficiency in the past, to pay more attention to fairness in the future. In addition, strengthen the adjustment of the third distribution, in order to promote the faster arrival of common prosperity.

The author believes that the next goal proposed by the CPC Central Committee is entirely timely; However, if we do not start from the most basic reform of the basic economic system, we will not be able to achieve the goal of common prosperity in a real and rapid way, but also leave uncleaned hidden dangers for the long-term development of China's economy. Because the existing economic system is not a scientific socialist social economic system that can consciously promote the development of socialized productive forces; It is all forms of capitalism that must be reformed and abandoned.

If the economic system reform of scientific socialism is carried out as mentioned above, no matter what the nature of the enterprises and the nature of the economic system are, the basic economic system with the three-third shareholding system as its basic content shall be carried out. The three components of socialized productive forces can exert their enthusiasm and consciousness actively and promote the rapid development of productive forces; In terms of equity allocation, although each member of the Human resource team has different social income such as salary (which has fundamentally reflected the principle of distribution according to work), they have the same status when they share one-third of the equity of the human resource team. While taking care of individual differences (wage differences), the system reflects the fairness of workers' social status in the process of production or service. The income difference also shrinks accordingly and it is beneficial to the common prosperity of the social group; In my contribution to the Third World Marxist Congress organized by Peking University, --"Marxism and Anti-Poverty Strategy", the author discusses this issue in detail; Interested readers may refer to it [5].

From the perspective of the whole society, if one third of the profits of the whole society are shared by all the labor teams, the income of workers will be significantly increased, and the social consumption level will also be significantly increased, which in turn will greatly promote the development of social production; This is the positive cycle of social consumption and production that can be caused and produced by the basic economic system of scientific socialism: it will promote the development of social production or services more and more, and the consumption level of social members will be more and more improved, constantly meeting people's expectations for a better social life; This is also the fundamental system guarantee that scientific socialism can defeat capitalism!!!

In the capitalist social system, since its basic economic system is capitalism, equity is distributed according to capital, and laborers can only accept the exploitation of capital. In capitalist society, production develops, but wealth is concentrated in the hands of capital, and the vast majority of workers have no conditions to consume. As a result, the relative overproduction unique to capitalist society arises, and the economic crisis follows; The capitalist economic system fundamentally determines that it is impossible to form a positive cycle of social production and consumption in the capitalist society. Therefore, it will inevitably perish and be replaced by the scientific socialist economic system.

After reforming the basic economic system of society according to the basic principle of scientific socialism, the common prosperity of the masses of laborers has the foundation of system guarantee. In addition, the state's macro-control at the social macro level and

the self-conscious adjustment of the third distribution will lead to the emergence of a social pattern in which the largest are in the middle class, richest and poorest classes are only a few and form the best social formation in the history of the Chinese nation and gradually realize the great rejuvenation of the Chinese nation.

Here, it is necessary to say a few words about China's land fiscal revenue; Because it involves the distribution of land revenue.

Land is a state asset and should be owned by the whole people. In the early stages of economic development, it was very clever to imitate capitalism by selling land to raise funds for economic development. However, in China's social practice, as China has been in a feudal society for a long time, the establishment of the Communist Party of China was in a semi-feudal, semi-colonial and colonial social environment, the inevitable historical traces, showing on the historical inertia of the ruling class and the corruption in the implementation of land finance are obvious; Moreover, the formation of interest groups of land developers and dignitaries with Chinese characteristics has created the historical strange phenomenon that China's real estate industry is one of the pillars of China's economy; That's why China's housing prices, in relative terms, are the highest in the world; Since the 18th National Congress of the Communist Party of China, the government has made every effort to bring down housing prices. But because the fundamental key is not grasped, the effect is not great.

So what is the fundamental key to lowering house prices? In fact, the majority of housing prices are the cost of land use. (With less land available for development, the price of land is of course rising.) But have you ever thought that the income from the sale of land should not belong to all the people? Why people buy a house, even should pay high use fees to the land originally belong to the people? The high fees paid through the hands of real estate developers, is finally handed over to the government; But the government has vowed that they want to bring down prices!! Perhaps only in China can we see such absurd and speechless phenomenon

The reason is: the rich and powerful collude with real estate developers so that both sides can get high returns from society, although some of them are illegal, but no one can pursue them; The government wants to get as much tax revenue as possible to make their lives easier (pay increases in welfare benefits); And with more money in their hands, governments can spend as they please; On the surface, spending by the Chinese government requires strict approval and audit, but in reality, the most critical decision on the direction of funds is actually made by the will of ministers. Its trend of unscientific and waste, is the key to the waste of funds; Such as spending a lot of money to prepare for foreign international conferences and so on, is a huge waste of money.

The key to reducing housing prices, from the fundamental principle, is to put the land fiscal revenue belongs to the whole people to the specific people, when they need to buy a house (we say the house here, is the rigid needs of the people housing, its due area, can be presided over by the state through legal procedures identified); That is the land financial income that the common people should get (or share) is used as the fund of the common people to buy a house (in fact, it is to offset the land use fee that should be paid originally - that is, the big part of the original house price).

(And these purchase funds voucher, can directly deduct the house price; And the real estate developer, can take these vouchers, as the voucher of pay development land use fee, hand over to the government, offset its place should pay land use fee;) (The author, in reference [1], had put forward a housing fund calculation method the common people should get when to buy a rigid need housing; Interested reader can refer to it.) In this way, when people buy a house, they actually only need to pay the real cost of building a house, and then, of course, the housing price will be greatly reduced, and they will be able to afford the housing they need.

When ordinary people want to buy non-rigid need house to use, the price and purchase of the non-rigid need house, of course, there is no country to return this part of the purchase fund, but must be in accordance with certain legal provisions and certain procedures to buy; Although there is no state to return the purchase of funds, but the right to use the land, China's domestic citizens certainly have some rights and interests, so they should get certain preferences within the legal scope; But for foreign enterprises and citizens, of course, there should be no similar preferential treatment to domestic citizens.

After the reform of the basic economic system and the implementation of housing funds for the rigid needs of the common people, the Chinese people can have a better life in the new era of socialism with Chinese characteristics.

I once wrote an article [6]. (This article was submitted to the external submission platform of Chinese Academy of Social Sciences. The status of this article is neither published nor rejected.) Its title is: "The slogan that can most stimulate the people's historical initiative and enthusiasm in the new period ----Operators have their rights, People have their right to live in their houses and Everyone is guaranteed!" [7].

If the reform of the basic economic system of true scientific socialism is carried out, every worker can share at least one third of the equity of the enterprise, isn't that the "Operators have their rights"? It can be realized on a large scale: if the land fiscal revenue owned by the whole people is returned by the housing purchase fund due to the people when they need to buy the housing they rigid need at a price they can afford; Isn't this the realization of the home ownership--"People have their right to live in their houses"; After the implementation of the development strategy of common prosperity and the third adjustment policy of distribution, "Everyone is guaranteed", of course, can be relatively easy to achieve. With the concerted efforts of the Chinese people, under the leadership of the Communist Party of China, such a happy life will surely come true!

Conclusion

As long as we continue to carry out in-depth reform and opening up under the leadership of the CPC Central Committee headed by Xi Jinping and carry out a thorough reform of China's basic economic system; The land finance necessary in the initial stage of development should be revised and improved accordingly, and the purchase funds that should be returned to the people returned timely and implement the strategy of common prosperity and conscientiously plan the policy of third distribution; Then On the basis of initially completing the building of a moderately prosperous

society, the Chinese people will surely have the most advanced social form of self-conscious development in the world, and gradually enjoy a better life where the employed have their rights, the residents have their homes, and everyone can enjoy security. And lead the human society of the whole world, gradually towards the conscious development stage of the human world community!
